Next week I leave without "my Judy", for a two-week trip to Costa Rica and Guatemala. My only message will be one of revival.

- In Costa Rica I will preach seven times, record four radio programs, record a thirty minute television program to be shown multiple times, and do a one-hour-interview on a Christian television network that reaches thirty-one countries. PLEASE PRAY THAT THIS TRIP WILL BE USED MIGHTILY OF THE LORD.
- In Guatemala, I have been asked to preach a revival message to several thousand pastors and leaders at the Annual National Convention of one of the largest denominations in that country.
 PLEASE PRAY THAT MANY WHO ATTEND THIS CONVENTION WILL BEGIN CRYING OUT TO THEIR LORD TO SEND REVIVAL TO GUATEMALA.

Through the gracious gift of a dear Christian friend from our college days, my airfare for all legs of this trip to Central America have been paid for, almost to the penny.

I had seriously contemplated riding the bus from Costa Rica to Guatemala to save that airfare for use in hotel and food expense.

Before the convention, both Judy and Rigo were adamant that I should not make that 24-hour bus trip across three countries.

As for Judy and me, we are praying that finances will allow us in October to return to Guatemala and begin going city by city preaching two consecutive nights until revival begins in that country.

Health and age concerns have resulted in many continuing to encourage me not to travel alone.

- While in Costa Rica, Rigo will be my constant companion.
- Due to lack of funds Judy cannot meet me in Guatemala to travel with me in that country. Especially pray for health and journeying mercies for this part of my trip.
