**I returned from Guatemala with mixed emotions. During this very intense period of time, God greatly blessed and used me for His glory. How can I explain all that occurred on this trip?**

**My fall, two weeks before this trip, along with the many hours of sitting in a chair at the convention exacerbated my pain to very high levels. I could not take anything for pain because it was necessary for me to be lucid and coherent at all times.**

**Why do I have mixed emotions? I am between a rock and a hard place. During the convention I received a large number of new invitations to preach in all parts of Guatemala. Before I left on this trip my cardiologist gave me strict orders to not travel, much less preach above 4500 feet. This has created a very difficult problem, because many of these churches are above 6000 feet.**

As you recall, a little over a month ago, I returned from preaching in Western Guatemala with a nitro-glycerin patch on my chest. I had preached seven times in three days, each time at an altitude above 6000 feet. Because of severe chest pain, I was unable to complete the original schedule of preaching ten times, in four days, in five cities. Today, I could not repeat that trip because of the altitude factor.

Conversations with many pastors attending the convention allowed me to understand how in the last three years our heavenly Father greatly blessed our time of ministry throughout Guatemala. In addition to teaching 18 pastors seminars to thousands of Guatemalan pastors, we have preached in more than 64 Guatemalan churches. I was blessed as many pastors greeted me with a hug and said, "Bendiciones (blessings) Don Carlos." Some of these pastors told me that they and members from their church had gone up on a mountain to pray all night, asking God to bless their country with a "great revival."

One pastor, who works at a Christian radio station, said his station has been playing my thirty- minute message on "Revival Praying" at a different time each day.

God has given me the faith to know that a great revival will begin in Guatemala this year (2010). When this revival begins I believe it will spread north and south to Christians in all of the countries in the Americas, including the United States. As this happens, we will begin seeing millions come to Christ.

I have believed that this great revival will begin in an area of Guatemala that is above 6000 feet. You cannot understand the anguish and

sadness I feel for now not being able to preach in that region of Guatemala.

During the convention, five pastors from the eastern or Caribbean lowlands of Guatemala asked me "when can you come to speak to all of the pastors in our area?" Pastors from other nearby areas also asked me to come to their area and preach in their churches. The altitude restriction has caused me to explore, before God, my accepting their invitations.

Travel in the low lands would be extremely painful for my neck, shoulder, back, and hip and I know for a certainty that I will need someone to travel with me. Finances and Judy's health kept her from making this last trip with me. Please pray that God will make it possible for Judy or Rigo to accompany me on this very difficult 2 to 3 week trip. Tentatively this trip would begin the third week of this month of October. PLEASE PRAY

Before I make this trip, God has impressed upon me to complete writing a small, very inexpensive to print, thirty-page booklet about Revival in Guatemala. This booklet explains what God expects of Guatemalan Christians before HE will bless their country with a great revival. A very important section of the booklet will be on "How to Pray for Revival". We are asking God to allow us to have at least 50,000 copies printed in Guatemala and then to distribute them throughout the country. PLEASE PRAY.

Rigo continues preaching evangelistic messages in different Costa Rican churches. He and I have been planning and organizing

evangelistic Crusades in Northern Colombia, a crusade at the border of Panama and Costa Rica, and a very large crusade in Huehuetenango, Guatemala.

We both have a great burden to hold a crusade this year in the Barriadas or slum areas of Lima, Peru. For this to happen, I need to fly to Lima ASAP, and together with our dear brother who is a City Councilman of Lima, make all of the arrangements. Our brothers' term in office ends in early December and after that date, bureaucratic red tape will preclude our holding this greatly anticipated highly fruitful crusade.

The people that live in slums of Lima, are people with no hope of ever having even the basic needs in life. They are very similar to the people in the market area of San Jose, Costa Rica , where in 1968 God first called Judy and I to minister. These poverty-stricken people need to hear that there is hope in Christ Jesus. PLEASE PRAY for me to be able to fly to Lima to organize and then for Rigo to hold this evangelistic crusade.

For the last two months, Rigo and I together, have been battling his family's financial problems. His telephone and then his water were turned off because he could not pay his bill. "We have robbed Peter to pay Paul and "Demas has forsaken us"! That is to say, we are doing everything possible to help Rigo and his young family to not only survive, but to do it victoriously. PLEASE PRAY for Rigo's children, that during this time of need they will learn more how to trust, by faith, in the grace of God.
